



Purchase and Sale Agreement
Critter Love

The following is the purchase and sale agreement dated: _____, 20_____

And Seller: _____ (“Seller”, “Critter Love”, “we”)

Concerning: _____ (“Pet”, “Sugar Glider” “Joey”)

IT IS AGREED BETWEEN BUYER AND SELLER AS FOLLOWS:

1. You (The “Buyer”, “Customer”, “Purchaser”), agree to buy from seller, (The “Seller”, “Critter Love”), or their agent, a Pet Sugar Glider. Critter Love reserves the right to refuse sale to anyone for any or no reason and will not enter into this agreement if the right of refusal is anticipated. Critter Love reserves the right to unilaterally cancel this agreement. Changes to the terms of this agreement may only be made with written bilateral agreement and must be signed by both parties.
2. PAYMENT: Payment in full of the agreed price is due and payable prior to delivery. Acceptable payment methods include cash, check, money order, and credit card or internet payments, in U.S. funds. Any revolving payment terms are as described in attachment A of this agreement.
3. DEPOSIT: A NON-REFUNDABLE reserve deposit totaling a minimum of \$100.00 or ½ (One-Half) the full purchase price, whichever is greater, is required to secure this purchase and is due within 24 hours of the agreement. Once the full deposit is received the Sugar Glider will be removed from potential sale and will be considered sold to you. The non-refundable deposit is credited in full to the purchase price and reduces the full purchase price by the amount of the deposit. If buyer wishes to cancel this agreement for any reason, and Critter Love agrees, the Non-refundable deposit will be forfeit and WILL NOT BE RETURNED to the buyer for any reason.
4. REFUNDS/RIGHT of FIRST REFUSAL: Refunds will only be issued due to cancellation by Critter Love, not the buyer. If Critter Love cancels this agreement a full refund of the deposit and any monies paid will be returned to the buyer. If within 60 days after delivery the buyer intends to sell the Sugar Glider, buyer agrees to offer Critter Love the right of first refusal with the selling price set at the original purchase price, less the non-refundable deposit.
5. DELIVERY: Joeys must be paid in full and scheduled for delivery or pickup between 8 to 10 weeks out of pouch. Specific date of delivery will be established and agreed to within a reasonable period following agreement.
6. HEALTH GUARANTEE: The Critter Love health guarantee can be found on the CritterLove.com website and should be read and understood prior to entering into this agreement. Live animal purchase carries risk and no other warranty is herein expressed or implied.
7. ENTIRE AGREEMENT: Buyer and Seller agree that this Agreement and attachment A (where applicable) supersedes, where inconsistent, conflicting or uncertain, any other provision of the Purchase and Sale. Buyer and Seller acknowledge that Critter Love is not and shall not be responsible for any representations, promises, understandings or agreements not contained in this Agreement and to which Critter Love is expressly made a party. Furthermore, that this Agreement is intended to fully incorporate all prior negotiations, discussions, understandings and promises whether between or involving Buyer, Seller, Critter Love or any other party or parties hereto.
